CAMEROONIAN TRAVEL DOCUMENT (LAISSEZ-PASSER)

The Embassy of Cameroon in the United States (Washington, DC) issues **Travel Documents** or **Laissez-Passer** to **eligible Cameroonian citizens** traveling to Cameroon, but who do not possess a valid passport. This "pass" enables prospective travelers whose passport is expired, damaged, or lost/stolen to be granted entry by immigration authorities at Cameroonian ports of entry. Applicants must reside in the area of jurisdiction of the Embassy of Cameroon in Washington, D.C.: the UNITED STATES of AMERICA, MEXICO, COSTA RICA, and the COMMONWEALTH of the BAHAMAS.

A Cameroonian Travel Document can be used for a one-way trip to Cameroon ONLY. It ceases to be valid as of the entry in Cameroon, where it is retained by the Border Police Authorities as its bearer is granted admission into the country.

(1) **PROCESSING TIME:** Approximately **SEVEN (07) business days**, excluding weekends and public holidays, starting on the time of reception of an **admissible application file**. Travelers should plan their trip accordingly and be aware that the processing time may extend over the Seven (07) business days during peak periods. **Incomplete files will be returned and will most likely experience serious delays as a result.**

Recommendation: APPLY EARLY! APPLY ONCE! Make sure you submit a complete/admissible file by carefully reviewing the information below.

(2) **APPLICATION PROCEDURE:** Applications must be submitted **BY MAIL ONLY no more than 90 days before the expected date of arrival in Cameroon**. The travel document will also be mailed back to the beneficiary once ready. Follow the steps (a), (b) and (c) below:

(b) **WHAT ARE THE DOCUMENTS TO SUBMIT?** **Be advised that Incomplete applications will be returned and experience significant delays.**

1. One printed copy of the present form with section (2)(a) above filled out, as cover page for your application file.
2. The current or expired passport; if an original passport is not available, photocopies are acceptable.
3. Two (02) copies travel document application forms filled out, dated and signed **[DO NOT FORGET TO SIGN AND DATE YOUR FORMS]**.
4. Two (02) recent (less than 3 months old) identical passport-size color photos with white background: Natural facial expression (mouth closed, no smiling or frowning); forehead and both ears clearly visible; Eyeglasses, face covering, headscarves or other accessories prohibited.
5. **Vaccination certificate showing proof of yellow fever immunization (this is not required for infants under 1 year old): or an exemption letter from a doctor if you cannot receive the yellow fever vaccination due to a medical contraindication.**
6. Copy of documents showing your residency status in the US or in your country of residence: Photocopy (front and back) of the green card or the work permit | For international students: Copy of the most recent form I-20, and a Letter from the International Students' Office of the school confirming that the student's F-1 status is active | For other cases: Copies of any available immigration notices/documents.
7. **Processing Fees:** A \$136.37 POSTAL MONEY ORDER payable to "Embassy of Cameroon". Please fill out the money order accurately.
8. Photocopy of the applicant's Cameroonian National Identity Card AND/OR Photocopy of the Cameroonian Birth Certificate.
9. Photocopy of the applicant's U.S. issued driver's license or state I.D. if available;
10. Copy of flight/trip reservation from airline or travel agency confirming the trip itinerary to Cameroon. Please take note of the following:
 - Travelers are advised to make only a reservation and not to purchase their ticket until the travel document is issued.
 - **Modification of travel itinerary:** A Travel Document will be accepted by the airline only for the travel details mentioned on the itinerary. If the trip itinerary is modified, the traveler must apply for a new travel document which requires a new payment of fees. In this case, **as part of the new application, the original of the previously issued travel document must be surrendered to the Embassy.**
11. **Travel Documents for minors (Under 21 years old):** For minors, the following is required in addition to previous requirements:
 - The application forms must be signed by a parent or a legal guardian and the nature of the relationship between the under-aged applicant and the signatory must be specified in parenthesis (Example: *father, mother, or legal guardian*); if the child is under the care of a legal guardian, photocopies of any documents assigning guardianship must be provided.
 - Photocopy of the child's birth certificate and of the parents/guardians' passports.
 - Notarized letter of support signed by both parents/legal guardians agreeing with the trip and specifying who is traveling with the child. **Parent/legal guardians who are in Cameroon** must provide a parental authorization legalized by the Police along with a certified copy of their valid national identity card OR of the identification page of their valid Cameroonian passport.
 - **Parent/legal guardians who are neither in Cameroon nor in the United States** must legalize the parental authorization at the nearest Cameroonian Embassy/Consulate, and provide a certified copy of the identification page of their Cameroonian passport.
12. For married women, a photocopy of their marriage certificate.
13. For any application, any additional document(s) deemed necessary for the processing of the request.

(c) **HOW AND WHERE TO MAIL THE APPLICATION FILE?:** 2 prepaid envelopes (Use FedEx, UPS or USPS) with tracking must be prepared:
The first envelope must be addressed from you (the applicant) to the Embassy and you will use it to mail your application file to the Embassy at:

The second prepaid envelope, addressed from the Embassy back to you, will be used to send you the document issued at the end of the process.

Please take extra care in making sure that the return envelope is prepaid, has a tracking number and is addressed correctly.
