### PROCURATION/POWER OF ATTORNEY/LEGALIZATION OF SIGNATURE

The Embassy of Cameroon in the United States (Washington, DC) performs various types of legalizations for applicants residing in its area of jurisdiction, which includes: the UNITED STATES of AMERICA, MEXICO, COSTA RICA, and the COMMONWEALTH of the BAHAMAS.

**Attention:** BE ADVISED THAT THE EMBASSY OF CAMEROON IN THE UNITED STATES (WASHINGTON, DC) DOES NOT PERFORM LEGALIZATIONS/CERTIFICATIONS OF FOREIGN DOCUMENTS.

- (1) **PROCESSING TIME:** Approximately FIVE (05) business days from the time of reception of an admissible application file.
- (2) **APPLICATION PROCEDURE:** BY MAIL ONLY. The document issued will also be mailed back to the recipient once ready. Follow the steps (a), (b) and (c) below:

(a) **Fill-out his section:**

(b) **Documents to submit:**

1. **A notarized written request addressed to the Ambassador:** The applicant must ask in writing (handwritten or typed request) that a power of attorney be legalized, or that a legalization of signature be performed for their benefit – In this request, the applicant should state for what purpose they will use the document requested, and include their contact information (*complete address, phone number and email address*).
  - This request must be signed before a notary public and notarized prior to mailing the application file to the Embassy.
2. **The Document (Power of Attorney/Procuration/or other document to legalize) signed by the applicant** – The applicant may print and fill out the procuration/power of attorney form available below OR write their own Document/Power of Attorney: when writing the Power of Attorney, please specify the type of ID [**Only a valid Cameroonian or foreign passport, Cameroonian National Identity Card, or Cameroonian Consular Card are accepted**], the number, date and place of issuance of said document, and the contact information (Complete address, phone number and email address) for both the applicant and the beneficiary of the procuration/power of attorney;
  - The written procuration/power of attorney **must NOT be notarized!**
  - For other types of certifications/legalizations not specified here, please contact the Consular Section prior to applying.
3. **For both the applicant and the beneficiary: Copy of VALID passport identification page AND/OR Copy of valid Cameroonian National Identity card (front and back), or copy of valid Cameroonian consular card (front and back);**
4. **a. If requesting a Power of attorney for matters related to a bank account, a piece of land, or other type of property: Provide proof of ownership** of the bank account (copy of bank statement, cancelled check, etc.), piece of land (copy of land title in owner's name), or proof of ownership of other type of property;  
**b. If requesting a parental authorization or power of attorney for matters related to the passport application of a minor child (under 21 years old) in Cameroon, provide a copy of the birth certificate of the child;**
5. **Copies of immigration documents indicating the applicant's residency status in the United States:**
  - For US citizens, copy of the biodata page of their US passport;
  - For permanent residents: **photocopy** of the green card;
  - For applicants whose case is awaiting a final decision, or about to start: provide copies of any available documents justifying that a procedure of adjustment of status is in progress or about to start;
  - For international students in American schools: **copy** of the most recent form I-20, along with a letter from the International Students Office of the school **confirming a current enrollment under the F-1 student status;**
  - For other cases: provide a copy of any available immigration documents.
6. **Fees: A \$5.46 POSTAL MONEY ORDER made payable to "Embassy of Cameroon".**
7. **Any additional document deemed necessary for processing the request. In this case, the Consular Section will contact you.**

- (c) **How and where to mail the application file?** 2 prepaid envelopes (Use FedEx, UPS or USPS) with tracking must be prepared: The first envelope must be addressed from the applicant to the Embassy, and will serve to mail the file to the Embassy at:

The second prepaid envelope, addressed from the Embassy back to the applicant, will serve to return the processed paperwork.

**Please take extra care in making sure that the return envelope is prepaid, has a tracking number and is addressed correctly.**
